- Have a correctly fitted muzzle (dogs with dog to dog aggression)
- Leads are safe and suitable for the weight and size of the dog

Del Mar Doggers will check collars, leads and tags during the consultation visit and before each walk. If any of the above are not complied with then **Del Mar Doggers** will be unable to walk your dog and fees will still apply for the scheduled service.
